Scrutiny of Nominations Paper on 30.10.2019


In terms of the Election Notice dated 17th October 2019, Scrutiny of Nomination Papers was held on 30.10.2019 from 11.00 a.m. as per schedule. The Nomination Forms so received on 24.10.2019 and 25.10.2019 by the candidates were recorded and the events of both days were recorded through videography. On 24.10.2019 total 44 nomination forms were received and on 25.10.2019 total 8 nomination forms were received upto 3.00 p.m. on both days. The closure of receipt of nomination forms were done in the presence of members and recorded by videography. In total 52 forms were received and 3 forms received at sl. No. 37, 38 and 39 were of same person viz. Sh. Raj Pal Singh Solanki. On the day of scrutiny, the process started in the presence of members which too was videographed. List of persons who filed Nomination Forms were displayed on the Notice Board of Society and website.

1. One by one the nomination papers were checked and three nomination papers on which the candidates have not put the date at the designated place or anywhere else under his name or signature viz. Dr. Rajinder Sura, Sh. Bhola Ram Chahar and Sh. Niranjana Singh, their forms were not found to be regular. In these cases, the Election Officer put his noting of non-compliance of Election Rules by the Candidates and hence rejected the same but with the written request of members present from all sides, the candidature of Sh. Rajinder Sura, Sh. Bhola Ram Chahar and Sh. Niranjana Singh have been approved.
2. In the case of Sh. Jagdish Ghanghas, the proposer has mentioned his name as Arum instead of Arun on which ground the nomination paper is liable to be put under 'not found to be regular'. But keeping in view the combined general request of the house, of error in writing, the Election Officer taking into consideration the aspect that the elections are in between the members of Society and such discrepancies should be avoided, approved the nomination form of Sh. Jagdish Ghanghas. **The Election Officer has also made it clear to the candidates that the names of the candidates should be as is shown in the membership list of the Society and they cannot deviate from their names mentioned therein. All members being agreed to this, have given their nod.**
3. It has also been decided and agreed by all candidates that the Ballot Paper carries the names of the Candidates in English as well in Hindi. The Hindi name should be below English name.

4. The Election Officer mentioned that the complaints with regarding to duplicacy in name of Sh. Gajender Singh has been rectified and only one name will appear in the list instead of two at sl. No. 1075 and 1092. He also informed the candidates that such dual name cases will be placed at single polling booth so that there may not be any confusion or fraud by any member for dual voting. He also informed that in this Elections, membership card issued by the Society (SMES) will not be valid and any other valid identity card, for which he is issuing separate notice, will be eligible for voting on 17.11.2019.
5. As regards the case of Sh. Jugvinder Singh who has filled the nomination form, his candidature is rejected due to the reasons that he has not put either the date or signature on the form. Since the candidate has not put his signatures, it will mean that he has not filed any nomination paper.
6. As regards, the case of Dr. Mahavir Singh Chhikara, the Election Officer is in receipt of representation that as per Clause 4(f) of the Society's Rules & Regulations, the membership of person ceases once he takes remunerative employment in the Institute or Society. As Dr. Mahavir Singh Chhikara was an employee (Director) of Maharaja Surajmal Institute, which is running under the aegis of Surajmal Memorial Education Society, his candidature cannot be considered for elections on 17.11.2019 being not member, and earlier membership prior to his employment stood automatically terminated.

With this, the Election Officer ended the meeting and asked the members to check from the notice board / website decision of validated candidature list on 30.10.2019 at 4.00p.m.

The members were also apprized about the decision taken on the objections.
